OUR SERVICES

Chartered Accountancy (CA)

PRIME CA arranges/provides the exam preparation classes for all levels: Foundation, Application and Advisory Levels of Chartered Accountancy course under ICAN. The classes are being conducted by experienced Chartered Accountants and experts in the respective subjects. As a part of its responsibility and to assess the students' level of understanding, and for their betterment, it conducts scholarship test / mock test in real examination settings for Foundation, Application and Advisory Levels.

Bachelor of Business Studies (BBS)

Chartered Accountancy is a professional course. Students pursuing chartered accountancy normally join BBS Course for academic degree. The most two reasons for joining BBS are:

- 1) For serving to government and corporate sectors as a chartered accountant, CA with graduation is required.
- 2) As completion of CA course normally takes time, and thus students can continue their education based on BBS.

Most of the people were unaware of Chartered Accountancy Profession and its importance. Statutory recognition is given to the CA and audit/certification is insisted upon for various purposes. Gradually, people are becoming more aware and interested in it. No wonder that the Chartered Accountancy is a high status profession and a passport to challenging and rewarding career in industry and commerce. Chartered Accountants are increasingly becoming an inseparable part of the top management level in all organizations whether they are public, private or government. Chartered Accountants can also set up an independent practice for Accounting, Auditing and Consultancy services. The society has increasingly recognized the services of Chartered Accountants in entire array of management consultancy including management accounting, management information and control systems, information technology and financial service sector. Accordingly, the demand for Chartered Accountants is growing higher. Instead of rendering professional services, the Chartered Accountants can join an industry or government organization and hold responsible position. Chartered Accountants are responsible for developing, analyzing and reporting information needed for business decisions. They also evaluate the financial effects of management's actions. A Chartered Accountant may also take up the job of providing education at College/University/Institute. Many Chartered Accountants hold responsible positions in business/ industrial organizations as CEO, Managing Director, Director Finance, Chief Accountant, Chief Internal Auditor etc. Chartered Accountants can also provide audit/certification work for various purposes in different statutes. HOW TO BECOME A CHARTERED ACCOUNTANT?

- >> Get registered with the Board of Studies of The Institute of Chartered Accounts of Nepal (ICAN).
- ▶ Be eligible to attend the exam.
- Attend and qualify the exams for all the levels held by the ICAN.
- ▶ Register for and complete the practical training as per the requirements.

Chartered Accountancy is a correspondence course. The basic study materials are provided by the ICAN on registration. The students have to study themselves and prepare for the exams. As self-study is found insufficient for complete preparation for the exams, students join Institutes like PRIME CA for the Exam Preparation Assistance.

CHARTERED ACCOUNTANCY COURSE UNDER THE INSTITUTE OF CHARTERED ACCOUNTANTS OF NEPAL (ICAN)

The Institute of Chartered Accountants of Nepal (ICAN) was established under the Nepal Chartered Accountants Act, 1997 to enhance social recognition and faith in the accounting profession by raising public awareness towards the importance of accounting profession as well as towards economic and social responsibility of the accountants, and to contribute towards economic development of the country. It is an autonomous body and is solely authorized to undertake accounting profession study in Nepal. Foundation Level is the basic level for Chartered Accountancy Course. After qualifying Foundation Level, students can join Application Level. Students who have done graduation/post-graduation with prescribed percentage can directly join Application Level. After qualifying Application Level, students can join Advisory Level. In Advisory Level, students have to undergo compulsory article-ship training for a period of three years. After qualifying Advisory Level along with completion of articleship, student becomes Chartered Accountant. So it will take around 5 years' duration to qualify Chartered Accountancy Course starting from Foundation Level.

It comes around Rs. 4,50,000 to Rs. 5,00,000 all together for CA with BBS including ICAN Registration Fee, Exam Fee, GMCS, AMCS, IT Fee, Tuition Fee, Study Materials and BBS Fee.

ELIGIBILITY FOR CHARTERED ACCOUNTANCY COURSE UNDER ICAN

The requirements for becoming a chartered accountant are as follows:

- i. Enroll with the ICAN for Foundation Level after passing 10+2 examination with at least 2.0 GPA. Students who have passed grade XI and appeared in the XII examination expecting to maintain at least 2.0 GPA can enroll provisionally.
- ii. Appear in Foundation Level exam after six months of registration. Examinations are held in June and December every year.
- iii. Join Application Level after passing Foundation Level. Students who have done graduation/post-graduation with 50 percentage can directly join Application Level.
- iv. Appear in Application Level Examination after 9 months of registration. Exams are held in June and December every year.
- v. Join Advisory Level course and 3-years articleship training after passing Application Level.
- vi. Appear in Advisory Level Examination after two years' completion of articleship period.
- vii. Qualify Advisory Level Examination and complete the period of articleship training.
- viii. Enroll for membership.

- ३. उपत्यकाभित्र सार्वजनिक सवारी साधन नचल्नेगरी घोषणा गरिएको बन्द तथा हडताल फिर्ता लिइएको खबर बेलुकी ८ बजे सम्मको समाचारमा प्रसारीत भएमा भोलिपल्ट बिहानी समुहका कक्षाहरु यथावत संचालन हुनेछन् साथै विहान ८ बजेसम्मको समाचारमा बन्द फिर्ताको ख<mark>बर प्रसारीत तथा प्रकाशित भ</mark>एमा दिवा समुहका कक्षाहरु यथावत संचालन हुनेछन् ।


